

Aquila Dental Referral Raffle

1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A purchase will not increase your odds of winning. All federal, state, local and municipal laws and regulations apply. Void where prohibited.

2. Sponsors. The Aquila Dental Referral Raffle is sponsored by Aquila Dental. Selection of winners and all other aspects of the Raffle shall be final and binding on entrant in all respects. Aquila Dental will not be responsible for typographical, printing or other inadvertent errors in these Official Rules or in other materials relating to the raffle. 3. Eligibility. The Aquila Dental Referral Raffle is open to individuals 18 years or older at the time of entry and is only open to legal residents of the 50 United States and District of Columbia. This Raffle is void outside the 50 United States and the District of Columbia, and where prohibited. Employees of New Image Dental and the immediate family members of, and any persons domiciled with such employees, are not eligible.

4. Entry. The raffle begins at 12:01 a.m. (E.S.T.) on February 1, 2016 and all entries must be received by 11:59 p.m. (E.S.T.) on December 31, 2016. Any referrals made in January will be included in February's raffle. Individuals are entered into this raffle by referring a new patient to Aquila Dental that comes in for an appointment. Each individual can enter each time they refer a new patient that comes in for an appointment and increase their chances of being chosen as a finalist. Only people who refer patients within that month can win that month. All participants are entered into the grand prize drawing. Aquila Dental reserves the right to disqualify any entries by persons determined to be tampering with or abusing any aspect of the raffle.

5. Prizes and Odds. One Grand Prize Winner will receive a Grand prize and will be chosen from the total number of referrals during the duration of the contest. The Grand Prize winner will be chosen on or around December 31, 2016. Monthly winners will receive a prize package from a local business. Odds of winning depend on the number of eligible entries received.

6. Winner Notification and Acceptance. Finalists will be notified by phone or email. If a potential winner does not respond to notification (with all requested information) within ten (10) days, such potential winner will be disqualified and an alternate winner will be selected.
